

Annual Listing of Authorized Projects – FY2023

The Birmingham Metropolitan Planning Organization (MPO) is required to provide an annual listing of the projects that have been authorized to expend funds. The list below shows the projects that were authorized (or obligated) for Fiscal Year 2023.

Approximately \$153 million were authorized in FY2023 in the MPO area. The following is a graph showing the distribution of authorized funding by category. Note each category has a separate Table Number which corresponds to the tables listed in the Transportation Improvement Program.
