1.0 EXECUTIVE SUMMARY

The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) conducted the site visit portion of the certification review of the transportation planning process for the Birmingham urbanized area on February 25, 2020. FHWA and FTA are required to jointly review and evaluate the transportation planning process for each urbanized area over 200,000 in population at least every four years to determine if the process meets the Federal planning requirements (23 CFR 450.336(b)).

1.1 Previous Findings and Disposition

The last certification review was completed in 2016. The 2016 Certification Review findings and their disposition are summarized as follows.

1.2 Summary of Current Findings

The current review found that the metropolitan transportation planning process conducted in the Birmingham urbanized area meets the Federal planning requirements.

As a result of this review, FHWA and FTA are certifying the transportation planning process conducted by Alabama Department of Transportation (ALDOT), the Birmingham Metropolitan Planning Organization (MPO), and the Birmingham-Jefferson County Transit Authority (BJCTA). There are recommendations in this report that warrant close attention and follow-up, as well as areas that MPO is performing very well in that are to be commended.

The following summary table provides a brief description of the certification findings for each area reviewed. Details of the certification findings for each of the following items are contained in sections 4.1 through 4.6 of this report.

2.0 INTRODUCTION

2.1 Background

Pursuant to 23 U.S.C. 134(k) and 49 U.S.C. 5303(k), the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) must jointly certify the metropolitan transportation planning process in Transportation Management Areas (TMAs) at least every four years. A TMA is an urbanized area, as defined by the U.S. Census Bureau, with a population of over 200,000. After the 2010 Census, the Secretary of Transportation designated 183 TMAs – 179 urbanized areas over 200,000 in population plus four urbanized areas that received special designation. In general, the reviews consist of three primary activities: a site visit, a review of planning products (in advance of and during the site visit), and preparation of a Certification Review Report that summarizes the review and offers findings. The reviews focus on compliance with Federal regulations, challenges, successes, and experiences of the cooperative relationship between the MPO(s), the State DOT(s), and public transportation operator(s) in the conduct of the metropolitan transportation planning process. Joint FTA/FHWA Certification Review guidelines provide agency field reviewers with latitude and flexibility to tailor the review to reflect regional issues and needs. Therefore, the scope and depth of the Certification Review reports will vary significantly.

The Certification Review process is only one of several methods used to assess the quality of a regional metropolitan transportation planning process, compliance with applicable statutes and regulations, and the level and type of technical assistance needed to enhance the effectiveness of the planning process. Other activities provide opportunities for this type of review and comment, including Unified Planning Work Program (UPWP) approval, the Metropolitan Transportation Plan (MTP), metropolitan and statewide Transportation Improvement Program (TIP) findings, air-quality (AQ) conformity determinations (in nonattainment and maintenance areas), as well as a range of other formal and less formal contact provide both FHWA/FTA an opportunity to comment on the planning process. The results of these other processes are considered in the Certification Review process.

While the Certification Review report itself may not fully document those many intermediate and ongoing checkpoints, the "findings" of Certification Review are, in fact, based upon the cumulative findings of the entire review effort.

The review process is individually tailored to focus on topics of significance in each metropolitan planning area. Federal reviewers prepare Certification Reports to document the results of the review process. The reports and final actions are the joint responsibility of the appropriate FHWA



and FTA field offices, and their content will vary to reflect the planning process reviewed, whether or not they relate explicitly to formal "findings" of the review.

To encourage public understanding and input, FHWA/FTA will continue to improve the clarity of the Certification Review reports.

2.2 Purpose and Objective

Since the enactment of the Intermodal Surface Transportation Efficiency Act (ISTEA) of 1991, the FHWA and FTA, are required to jointly review and evaluate the transportation planning process in all urbanized areas over 200,000 population to determine if the process meets the Federal planning requirements in 23 U.S.C. 134, 40 U.S.C. 5303, and 23 CFR 450. The Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU), extended the minimum allowable frequency of certification reviews to at least every four years.

The Birmingham Metropolitan Planning Organization is the designated MPO for the Birmingham urbanized area. Alabama Department of Transportation (ALDOT) is the responsible State agency. The Birmingham-Jefferson County Transit Authority (BJCTA) is the responsible public transportation operator. Current membership of the Birmingham MPO consists of elected officials and citizens from the political jurisdictions in the City of Birmingham, Unincorporated Jefferson County, Blount County, St. Clair County, City of Pleasant Grove, City of Hoover, City of Trussville, Shelby County, City of Vestavia Hills, City of Graysville, City of Helena, City of Alabaster, City of Center Point, City of Gardendale, City of Fultondale, Town of Brookside, City of Warrior, City of Midfield, Town of Sylvan Springs, City of Tarrant, and City of Pelham. ALDOT and BJCTA are also members of the Birmingham MPO. The Birmingham Metropolitan Planning Area (MPA) includes the geographic area of all the aforementioned cities and towns with the City of Birmingham as the largest population center.

Certification of the planning process is a prerequisite to the approval of Federal funding for transportation projects in such areas. The certification review is also an opportunity to provide assistance on new programs and to enhance the ability of the metropolitan transportation planning process to provide decision makers with the knowledge they need to make well-informed capital and operating investment decisions.



3.0 SCOPE AND METHODOLOGY

3.1 Review Process

The last certification review was completed in 2016. A summary of the status of findings from the last review is provided in Section 1.1 of this report. This report details the most recent review, which consisted of a formal site visit and a public involvement opportunity, conducted in February 2020.

Participants in the review included representatives of FHWA, FTA, Environmental Protection Agency (EPA), ALDOT, the BJCTA, and the Birmingham MPO staff. A full list of participants is included in Appendix A.

A desk audit of current documents and correspondence was completed prior to the site visit. In addition to the formal review, routine oversight mechanisms provide a major source of information upon which to base the certification findings.

The Federal Review Team utilized a risk-based approach to determine which subject areas required additional evaluation during the certification review. The certification review covers the transportation planning process conducted cooperatively by the MPO, State, and public transportation operators. Background information, current status, key findings, and recommendations are summarized in the body of the report for the following subject areas selected by FHWA and FTA staff for the on-site review:

- MPO structure and agreements
- Transit planning and programming
- Public involvement
- Title VI, Nondiscrimination, Environmental Justice, ADA, and Limited English Proficiency
- Air quality and Congestion Mitigation and Air Quality (CMAQ) Improvement Program
- Active or inactive projects including Annual Listing of Obligated Projects within the Metropolitan Planning Area (MPA)

4.0 PROGRAM REVIEW

4.1 MPO Structure and Agreements

4.1.1 Regulatory Basis

23 U.S.C. 134(d) and 23 CFR 450.314(a) state the MPO, the State, and the public transportation operator shall cooperatively determine their mutual responsibilities in carrying out the metropolitan transportation planning process. These responsibilities shall be clearly identified in written agreements among the MPO, the State, and the public transportation operator serving the MPA.

4.1.2 Current Status

The Birmingham Metropolitan Planning Organization (MPO) was founded in 1963. The MPO is housed in the Regional Planning Commission of Greater Birmingham (RPCGB), and staffed by RPCGB employees who are responsible for assisting in completion of all required planning and programming of the transportation system for the Birmingham MPA.

The Birmingham MPO is the lead agency responsible for determining overall policy affecting long-range and short-range transportation programs and plans for the TMA. The MPO Policy Committee is composed of forty-four (44) voting members and three (3) non-voting members. Voting membership consists of (each member has one vote):

The MPO Policy Committee meetings are scheduled every month. The advisory committee associated with the transportation planning process in the Birmingham MPO includes a Transportation Technical Committee (TTC), and a Transportation Citizens Committee (TCC). Prior to making decisions, the MPO Policy Committee receives technical guidance and structured citizen input from the TTC and TCC.

The Birmingham-Jefferson County Transit Authority is the main public transit provider for the Birmingham metropolitan area. The Chairman of the BJCTA Board of Directors serves as the transit representative through the MPO Policy Committee.

MPO has four active agreements and three bylaws:

 The first agreement is between the MPO membership governments and the State of Alabama regarding the "3C Planning Process", also known as the 3C agreement, was updated and signed in 2015;



- The second agreement is between the State of Alabama and the RPCGB regarding the administration of USDOT transportation planning funds, was signed in 2008;
- The third agreement is between the MPO and the State of Alabama regarding the performance measures and targets, was signed in 2018;
- The fourth agreement is between RPCGB and BJCTA regarding the administration of FTA Section 5310 grant funding, was signed in 2016;
- The MPO Policy Committee bylaws briefly describe the membership, membership requirements, and roles and responsibilities of the MPO, was last amended in 2015;
- The TTC bylaws briefly describe the membership, membership requirements, and roles and responsibilities of the TTC, was last revised in 2013;
- The TCC bylaws briefly describe the membership, membership requirements, and roles and responsibilities of the TCC, was last amended in 2017.

The Federal Team made the following observations regarding the agreements and bylaws of the MPO:

- None of the written agreements between RPCGB and ALDOT includes "specific provisions for the development of financial plans that support the metropolitan transportation plan and the metropolitan TIP, and development of the annual listing of obligated projects" as required by 23 CFR 450.314 (a);
- The MPO is in the process of becoming a designated recipient of FTA Section 5310 grant funding. The existing agreement between RPCGB and BJCTA concerning the administration of FTA 5310 funds may need an update to reflect the current practice once the MPO receives its official designation as a designated recipient of FTA 5310 funds.

4.1.3 Findings

Commendation: None

Corrective Action: None

Recommendations:

• The MPO, ALDOT, and BJCTA should work together to include in their agreement specific provisions for the development of financial plans that support the Metropolitan



Transportation Plan (MTP) also known as the Regional Transportation Plan (RTP) and the metropolitan TIP, and development of the Annual Listing of Obligated Projects as required in 23 CFR 450.314 (a). Since the contents of the agreement between ALDOT and every MPO in the State of Alabama are the same except for signature authorities, missing of required provisions in agreement is a statewide issue and should be addressed across the board;

Once the MPO receives its official designation as a designated recipient of FTA 5310 funds, the MPO and BJCTA should assess the status of the agreement concerning the administration of FTA Section 5310 grant funding, and make necessary changes to the agreement to reflect current practice if needed.

<u>Schedule for Process Improvement:</u> Recommendation concerning the MPO's agreement with ALDOT should be addressed by the next update of the agreement. Recommendation concerning the agreement between RPCGB and BJCTA for the administration of FTA 5310 funds should be addressed by July 2021 or as needed.

<u>Proposed FHWA/FTA Technical Assistance:</u> FHWA and FTA will provide technical assistance as requested.

4.2 Transit Planning and Programming

4.2.1 Regulatory Basis

49 U.S.C. 5303 and 23 U.S.C. 134 require the transportation planning process in metropolitan areas to consider all modes of travel in the development of their plans and programs. Federal regulations cited in 23 CFR 450.314 state that the MPO in cooperation with the State and operators of publicly owned transit services shall be responsible for carrying out the transportation planning process.

4.2.2 Current Status

The Birmingham MPO and BJCTA worked closely in the development of the 2045 Regional Transportation Plan (RTP). The RTP described that the Birmingham metropolitan area is partially served by fixed-route public transit and complementary paratransit. Demand response service is available throughout Jefferson and Shelby counties for those who are elderly or disabled. The Birmingham Jefferson-County Transit Authority (BJCTA) operates only fixed-route public transportation service, and serves several cities within the Birmingham metropolitan area.



The transit services provided by the BJCTA are funded through a variety of sources, including contributions from cities served by BJCTA routes, FTA grants and local taxes. The BJCTA developed and completed a Transit Development Plan (TDP) which identifies service needs, prioritizes improvements, and determines the resources required for implementing modified or new services. The City of Birmingham, in partnership with the FTA, and BJCTA is developing a Bus Rapid Transit (BRT) project which could potentially provide transit service and connection to 25 neighborhoods within the Birmingham metropolitan area.

The Federal Team made the following observations regarding the process used by the MPO to flex CMAQ, and Surface Transportation Block Grant (STBG) Program funds:

- Under the Federal-aid Highway Program, States may obligate Federal Highway funds, under certain conditions, to purchase transit vehicles that are also eligible for financial assistance under FTA's funding programs. The Congestion Mitigation and Air Quality Improvement Program (CMAQ) funds may be transferred to the FTA for use in transit projects. Several CMAQ transfers to FTA were made in Birmingham during Fiscal Year 2019. The formal process used by the BJCTA, MPO, and ALDOT for requesting CMAQ funds to be transferred to FTA is not documented by the BJCTA or MPO. The MPO and ALDOT described the process as follows:
 - The BJCTA submits a request to the MPO for review and approval;
 - ➤ The MPO submits the information provided on the request by BJCTA to ALDOT East Central Region;
 - ➤ ALDOT East Central Region enters the information into its Comprehensive Project Management System (CPMS) and generates a project number;
 - ➤ The MPO approves BJCTA's request as a formal TIP amendment, then submits the request to ALDOT Central Office;
 - > ALDOT Central Office submits formal request to FHWA for CMAQ funds to be transferred to FTA.
- The MPO also flexed dedicated STBG funds to the Birmingham urbanized area to the City of Birmingham for various transit projects, such as Bus Rapid Transit (BRT), and intermodal facility. The process to flex STBG funds for transit projects is not documented by the MPO.

4.2.3 Findings

Commendation: None



Corrective Action: None

Recommendation:

 The MPO, BJCTA, and municipalities should document the process for requesting CMAQ, and Surface Transportation Block Grant (STBG) Program funds to be flexed for transit projects so all parties involved understand the process, their respective roles and responsibilities in the process, and follow the process.

<u>Schedule for Process Improvement:</u> The MPO and BJCTA should implement the recommendation by the next Certification Review.

<u>Proposed FHWA/FTA Technical Assistance:</u> FHWA and FTA will provide technical assistance as requested.

4.3 Public Involvement

4.3.1 Regulatory Basis

Sections 134(i)(5), 134(j)(1)(B) of Title 23 and Section 5303(i)(5) and 5303(j)(1)(B) of Title 49, require a Metropolitan Planning Organization (MPO) to provide adequate opportunity for the public to participate in and comment on the products and planning processes of the MPO. The requirements for public involvement are detailed in 23 CFR 450.316(a) and (b), which require the MPO to develop and use a documented participation plan that includes explicit procedures and strategies to include the public and other interested parties in the transportation planning process.

Specific requirements include giving adequate and timely notice of opportunities to participate in or comment on transportation issues and processes, employing visualization techniques to describe metropolitan transportation plans and TIPs, making public information readily available in electronically accessible formats and means such as the world wide web, holding public meetings at convenient and accessible locations and times, demonstrating explicit consideration and response to public input, and a periodically reviewing of the effectiveness of the participation plan.

4.3.2 Current Status

The MPO's Public Participation Plan was last updated in 2014, and the MPO is aware that the plan needs an update to incorporate newer information. Since the last TMA



Certification in 2016, the Birmingham MPO has revamped its official website to include additional information related to Title VI and complaint procedures, past MPO meeting minutes, and project information with interactive mapping for TIP. The MPO also conducted extensive public outreach during the development of its bicycle and pedestrian plan, freight plan, and 2045 RTP by using both paper and online surveys, social media, website, local radio and TV interviews, and in person workshops and meetings at the MPO and other public locations where people were most likely to show up.

The MPO's public outreach effort was successful, and generated substantial amount of participation, and input from the public. The most notable practices include the MPO publishing an annual state of the network report to keep the public informed of any progress made in implementing the B-Active Plan which is the MPO's adopted bicycle and pedestrian plan, as well as promoting the B-Active Plan in 3 local radio, and more than 10 TV interviews. The B-Active Plan received the "2017 Outstanding Media Coverage" Award by the Alabama Chapter of the American Planning Association.

The Federal Review Team held one public involvement meeting during the TMA Certification on-site review to provide an opportunity for the public to voice their opinions, concerns, and questions about the MPO's planning process. Comments from the public involvement meeting are included in Appendix B of this report.

4.3.3 Findings

Commendation:

- Citizens participated at the public involvement meeting during the TMA Certification onsite review commended the MPO staff for their responsiveness and professionalism;
- The MPO staff was enthusiastic, receptive and accommodating throughout the certification review;
- The MPO's approach to involve and engage the public was innovative, creative, and effective during the development of the B-Active Plan, Freight Plan, and 2045 RTP. The amount of participation and input from the public was substantial.

Corrective Action: None

Recommendation:

• The MPO should update the PPP to replace outdated information with current information.



<u>Schedule for Process Improvement:</u> The MPO should implement the recommendation by the next Certification Review.

<u>Proposed FHWA/FTA Technical Assistance:</u> FHWA and FTA will provide technical assistance as requested.

4.4 Title VI, Nondiscrimination, Environmental Justice, ADA, and Limited English Proficiency

4.4.1 Regulatory Basis

Self-Certification of the metropolitan planning process, at least once every four years, is required under 23 CFR 450.336. The State and the MPO shall certify to FHWA and FTA that the planning process is addressing the major issues facing the area and is conducted in accordance with all applicable requirements. These requirements include but are not limited to Title VI, Environmental Justice (EJ), Limited English Proficiency (LEP), and ADA.

Title VI of the Civil Rights Act of 1964, prohibits discrimination based upon race, color, and national origin. Specifically, 42 U.S.C. 2000d states that "No person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance." In addition to Title VI, there are other Nondiscrimination statutes that afford legal protection. These statutes include the following: Section 162 (a) of the Federal-Aid Highway Act of 1973 (23 U.S.C. 324), Age Discrimination Act of 1975, and Section 504 of the Rehabilitation Act of 1973/Americans with Disabilities Act (ADA) of 1990. ADA specifies that programs and activities funded with Federal dollars are prohibited from discrimination based on disability.

Executive Order #12898 (Environmental Justice) directs federal agencies to develop strategies to address disproportionately high and adverse human health or environmental effects of their programs on minority and low-income populations. In compliance with this Executive Order, USDOT and FHWA issued orders to establish policies and procedures for addressing environmental justice in minority and low-income populations. The planning regulations, at 23 CFR 450.316(a)(1)(vii), require that the needs of those "traditionally underserved" by existing transportation systems, such as low-income and/or minority households, be sought out and considered.



Executive Order # 13166 (Limited-English-Proficiency) requires agencies to ensure that limited English proficiency persons are able to meaningfully access the services provided consistent with and without unduly burdening the fundamental mission of each federal agency.

4.4.2 Current Status

The Birmingham MPO completed its last self-certification in 2019 in conjunction with its quadrennial TIP update. The MPO Policy Committee and ALDOT verified the self-certification. The MPO does not have any active or previously unresolved Title VI, ADA, or DBE formal complaints. All MPO planning documents and actions are made available for public review and comments prior to adoption. All MPO regularly scheduled meetings are held at a location that is ADA compliant, and accessible to the public. Contact information is also made available in all planning documents and at the MPO's website.

The MPO has an adopted ADA transition plan, and submits each year information related to Nondiscrimination, EJ, ADA, DBE and LEP to ALDOT for inclusion in ALDOT's Title VI Implementation Plan. In addition, the MPO assisted all 59 member governments in the development of ADA Transition Plans for their respective areas. Out of the 59 member governments, thirteen (13) have completed their ADA Transition Plans, nine (9) have self-certified as ADA compliant, and the rest are still working on getting their ADA Transition Plans completed.

The Federal Team made the following observations regarding the MPO's processes in selecting consultant, and reporting DBE usage to ALDOT:

- Although, the MPO's consultant selection process gives more points to applicants that have DBE certification, the MPO's final selection of a consultant is mainly based on the overall qualification of the consultant;
- The MPO reports DBE usage to ALDOT annually, but is unfamiliar with how the DBE is counted toward ALDOT's overall DBE goal;
- The MPO is unfamiliar with ALDOT's Unified Certification Program (ALUCP) and the ALUCP directory. The ALUCP is a certification process that allows applicants for the DBE program to apply only once for a DBE certification that will be honored by all recipients of the Federal-Aid Highway Program and FTA grants in the State of Alabama. The ALUCP directory provides a list of companies that are DBE certified to perform work in the State of Alabama.



4.4.3 Findings

<u>Commendation</u>: The MPO led and assisted all 59 member governments in the development of ADA Transition Plans for their respective areas.

Corrective Action: None

Recommendations:

• The weakness shown in the DBE reporting process reflects the need for intense training of all MPO personnel, and comprehensive DBE program development.

<u>Schedule for Process Improvement:</u> The MPO should implement the recommendation by the next Certification Review.

<u>Proposed FHWA/FTA Technical Assistance:</u> FHWA presented Title VI requirements at the annual Alabama Transportation Planners Association (ATPA) conference held in March 2020. FHWA and FTA will continue to provide technical assistance as requested.

4.5 Air Quality and CMAQ Improvement Program

4.5.1 Regulatory Basis

Section 176 (c)(1) of the Clean Air Act Amendments of 1990 (CAAA) states: "No metropolitan planning organization designated under section 134 of title 23, United States Code, shall give its approval to any project, program, or plan which does not conform to an implementation plan approved or promulgated under section 110." The Intermodal Surface Transportation Efficiency Act of 1991 subsequently included provisions responsive to the mandates of the CAAA. Implementing regulations have maintained this strong connection.

For MPOs that are designated to be air quality nonattainment or maintenance areas, they are required under the Clean Air Act to comply with the requirements of 40 CFR part 93. The metropolitan planning regulations governing air quality are summarized below.

- An agreement is required between the MPO and the designated agency responsible for air quality planning describing their respective roles and responsibilities. [23 CFR 450.314(c)]
- In a metropolitan area that does not include the entire nonattainment or maintenance area, an agreement is required among the State DOT, State air-quality agency, affected



local agencies, and the MPO providing for cooperative planning in the area outside the metropolitan planning area but within the nonattainment or maintenance area. [23 CFR 450.314(c)] In metropolitan areas with more than one MPO, an agreement is required among the State and the MPO describing how they will coordinate to develop an overall Metropolitan Transportation Plan (MTP) for the metropolitan area; in nonattainment and maintenance areas, the agreement is required to include State and local air-quality agencies. [23 CFR 450.314(e)]

- The MPO is required to coordinate development of the MTP with the State Implementation Plan (SIP) development process, including the development of Transportation Control Measures (TCMs). [23 CFR 450.324(d)]
- In TMAs designated as nonattainment areas, Federal funds may not be programmed for any project that will result in a significant increase in carrying capacity for SOVs, unless the project results from a Congest Management Process (CMP) meeting the requirements of 23 CFR 450.322(d) and (e)
- The MTP shall identify SOV projects that result from a CMP meeting Federal requirements, [23 CFR 450.324(f)(6)] and shall include design-concept and scope descriptions of all existing and future transportation facilities to permit conformity determinations. [23 CFR 450.324(f)(9)] FHWA, FTA, and the MPO must make a conformity determination on any new or revised MTP in nonattainment and maintenance areas (see Metropolitan Transportation Plan topic area). [23 CFR 450.324(m)]
- In nonattainment and maintenance areas, FHWA, FTA and the MPO must make a conformity determination on any new or amended TIP. [23 CFR 450.326(a), 450.328(a), and 450.330(b)]
- In nonattainment TMAs, there must be an opportunity for at least one formal public meeting during the TIP development process. [23 CFR 450.326(b)]
- In nonattainment and maintenance areas, the TIP shall identify projects designated as TCMs in the applicable SIP. [23 CFR 450.326(g)(5)]
- In nonattainment and maintenance areas, the TIP shall include all regionally significant transportation projects proposed to be funded with Federal and non-Federal funds [23 CFR 450.326(f)] as well as projects identified as TCMs in the SIP. [23 CFR 450.326(g)(5)] Projects shall be specified in sufficient detail to permit air-quality analysis in accordance with EPA conformity requirements. [23 CFR 450.326(g)(6)]



- In nonattainment and maintenance areas, the TIP shall describe the progress in implementing required TCMs [23 CFR 450.326(n)(3)] and shall include a list of all projects found to conform in a previous TIP that are now part of the base case used in the air-quality conformity analysis. [23 CFR 450.326(n)(2)]
- In nonattainment or maintenance areas, if the TIP is amended by adding or deleting projects that affect transportation-related emissions, a new conformity determination will be required. [23 CFR 450.328(a)]
- In TMAs that are nonattainment or maintenance areas, FHWA and FTA will review and evaluate the transportation planning process to determine that it is adequate to ensure conformity of plans and programs in accordance with procedures contained in 40 CFR part 93. [23 CFR 450.336(b)]

The Congestion Mitigation and Air Quality Improvement Program (CMAQ) provides a flexible funding source to State and local governments for transportation projects and programs to help meet the requirements of the Clean Air Act. Funding is available to reduce congestion and improve air quality for areas that do not meet the National Ambient Air Quality Standards for ozone carbon monoxide, or particulate matter (nonattainment areas) and for former nonattainment areas that are now in compliance (maintenance areas). Funds may be used for a transportation project or program that is likely to contribute to the attainment or maintenance of a national ambient air quality standard, with a high level of effectiveness in reducing air pollution, and that is included in the metropolitan planning organization's (MPO's) current transportation plan and transportation improvement program (TIP). [23 U.S.C. 149]

4.5.2 Current Status

After approving Alabama's maintenance plan, the U.S. Environmental Protection Agency (EPA) redesignated Jefferson and Shelby Counties as maintenance areas for the 1997 8-hour ozone (O₃) National Ambient Air Quality (NAAQS) in 2006, and redesignated Jefferson County, Shelby County and a portion of Walker County as maintenance areas for annual fine particulate matter (PM_{2.5}) NAAQS, and 24-hour PM_{2.5} NAAQS in 2013. As a maintenance area, the area must comply with the transportation conformity provisions of the Clean Air Act for the period of the maintenance plan (20 years). Transportation conformity is a way to ensure that Federal funding and approval go to those transportation activities that are consistent with the air quality goals: to eliminate violations, reduce the frequency and severity of violations and reach attainment in a timely manner. Therefore, the Birmingham MPO is required to conduct a regional emissions analysis showing that the RTP and TIP comply with the State Implementation Maintenance plan for the PM_{2.5} NAAQS until 2033, and for the O₃ NAAQS until 2026.



The MPO completed the Air Quality Conformity Determination in conjunction with update to its Regional Transportation Plan and TIP in 2019. The MPO's conformity process is done in accordance with the required interagency consultation (IAC) process, and the criteria and procedures outlined in the IAC agreement signed by all members of the IAC including the Birmingham MPO, RPCGB, ALDOT, Alabama Department of Environmental Management (ADEM), Jefferson County Department of Health, BJCTA, FHWA, FTA and EPA.

The Birmingham metropolitan planning area is the only designated air quality maintenance area in the State of Alabama, therefore the only area that receives CMAQ funds. The RPCGB created two initiatives, the CommuteSmart, and Alabama Partners for Clean Air (APCA). Both initiatives are funded by CMAQ funds. The CommuteSmart program was created to help alleviate traffic congestion and reduce air pollution in the Birmingham metropolitan area by educating commuters on cleaner modes of transportation which may include carpooling, vanpooling, bicycling, walking, teleworking and public transit. The APCA was formed to achieve and maintain compliance with national air quality standards, to protect and improve public health, to minimize the economic impacts on existing businesses and support economic growth.

In addition to these initiatives, the MPO also uses CMAQ funds on a variety of projects intended to improve air quality. The MPO solicits, selects, and then programs projects funded with CMAQ funds in the MPO's TIP using the same project selection process for other types of projects to be included in the TIP. The MPO sends the list of projects funded with CMAQ funds to IAC for eligibility determination, review and comments. The MPO also sends all new federal aid projects regardless of funding source to IAC for review of exemption from Hot Spot analyses.

The MPO stated that project selection for TIP is primarily based on the ten planning factors of the FAST Act, as well as the performance targets that ALDOT has set, and the MPO has adopted for safety performance (PM1), infrastructure condition (PM2), system performance (PM3), and Transit Asset Management. The MPO has decided not to prioritize projects in the TIP with the understanding that all projects in the TIP are of equal importance for the region.

The Federal Team made the following observations regarding the air quality conformity process and CMAQ Improvement Program of the MPO:

 The Memorandum of Agreement for Interagency Consultation (IAC) for Air Quality Conformity was signed and taken into effect in 2007. Several people who signed the agreement in 2007 are no longer representing the agencies that are members of the



- IAC. The written roles and responsibilities of each agency in the agreement may no longer reflect what is currently in practice;
- The MPO's decision not to prioritize projects may underestimate the impact of projects on air quality, and consequently the MPO may miss giving priority to projects that could potentially reduce mobile source emissions, and improve the overall air quality for the region in the long run.

4.5.3 Findings

<u>Commendation</u>: The RPCGB provides and leads two major initiatives, CommuteSmart and Alabama Partners for Clean Air to promote cleaner modes of transportation, and improve air quality for the Birmingham metropolitan planning area.

Corrective Action: None

Recommendations:

- Together, the members of the IAC should review the Memorandum of Agreement (MOA) for Interagency Consultation (IAC) for Air Quality Conformity, and update the agreement as necessary to ensure the written roles and responsibilities of each member reflect what is in practice;
- The MPO is encouraged to consider the impact to air quality in its project selection process.

<u>Schedule for Process Improvement:</u> The MPO should implement the recommendations by the next Certification Review.

<u>Proposed FHWA/FTA Technical Assistance:</u> FHWA, FTA, and EPA will provide technical assistance as requested.

4.6 Active or Inactive Projects Including Annual Listing of Obligated Projects Within the Metropolitan Planning Area (MPA)

4.6.1 Regulatory Basis

23 U.S.C. 134(j)(7) and 23 CFR 450.334 requires that the State, the MPO, and public transportation operators cooperatively develop a listing of projects for which Federal funds under 23 U.S.C. or 49 U.S. C. Chapter 53 have been obligated in the previous year. The listing



must include all federally funded projects authorized or revised to increase obligations in the preceding program year and, at a minimum, the following for each project:

- The amount of funds requested in the TIP
- Federal funding obligated during the preceding year
- Federal funding remaining and available for subsequent years
- Sufficient description to identify the project
- Identification of the agencies responsible for carrying out the project

2 CFR 200.343 requires the Federal awarding agency or pass-through entity to close-out the Federal award when it determines that all applicable administrative actions and all required work of the Federal award have been completed by the non-Federal entity. The Federal awarding agency or pass-through entity should complete all closeout actions for Federal awards no later than one year after receipt and acceptance of all required final reports. Project agreement end date is required for projects that have been authorized after December 26, 2014. Final costs for a project must be billed and obligations liquidated within 90 days of the project end date, and work performed after project end date is not allowable.

4.6.2 Current Status

The FHWA and FTA conducted a Federal Planning Finding review in conjunction with the approval of the Statewide Transportation Improvement Program (STIP) in 2019. Based on the review, the FHWA and FTA issued a corrective action to ALDOT, and the MPOs concerning the MPO's Annual Listing of Obligated Projects. At the time when the Federal Planning Finding review was conducted, the Annual Listing of Obligated Projects developed and published by each MPO lacked required information as mandated by 23 CFR 450.334. The Annual Listing of Obligated Projects developed and published by each MPO for 2018 did not include the following required information:

- the amount of Federal funds requested in the TIP;
- the Federal funding that was obligated during the preceding year;
- and the Federal funding remaining and available for subsequent years for each authorized project.

Each MPO uses the MPO Portal, a web-based application developed by ALDOT to generate the Annual Listing of Obligated Projects, and relies on ALDOT to provide Federal funding information, such as obligated and expended amount in the preceding year, and remaining and available amount for subsequent years for each authorized project. The corrective action required ALDOT to make the reporting mechanism easy for MPOs to use, and provide



each MPO sufficient information to develop and publish a complete Annual Listing of Obligated Projects. The corrective action required each MPO to include in its Annual Listing of Obligated Projects the amount of Federal funds requested in the TIP, the Federal funding that was obligated during the preceding year, and the Federal funding remaining and available for subsequent years for each authorized project. The corrective action also required each MPO to include in its Annual Listing of Obligated Projects all project phases (PE, RW, UT, CN), the obligated Federal amount for each project phase, and the remaining amount of required funding to complete the entire project for each individual project.

ALDOT has since made significant progress toward addressing the corrective action, and assisted each MPO in its development of Annual Listing of Obligated Projects for 2019. The Birmingham MPO's Annual Listing of Obligated Projects developed and published for 2019 provides all the required information, in accordance with 23 CFR 450.334.

In addition to the review of the MPO's Annual Listing of Obligated Projects, the Federal Review Team provided the MPO a list of all active projects for the Birmingham MPA (see Appendix D), and requested the MPO to provide the following information for each of these projects:

- Project sponsor;
- Description of project status (completed or closed, delayed due to NEPA or PE, inactivity, lack of funding, inactivity, waiting to be closed out, or whichever the case may be);
- Proposed project starting date for RW, UT, CN phases in the MPO's TIP if PE phase of the project has already been authorized.

The MPO worked with ALDOT East Central Region to obtain project information for each project listed on the list of all active projects. The MPO provided project status for projects funded with dedicated STBG funds to the Birmingham MPO, and had to rely on ALDOT East Central Region to provide project status on projects that were either sponsored by ALDOT, or municipalities.

The MPO currently receives an automated email notification from ALDOT whenever a change is made to a project for the Birmingham urbanized area. The MPO also receives a monthly urban funds report from ALDOT that provides a running balance of dedicated STBG funds to the Birmingham urbanized area. In addition, the MPO works with ALDOT East Central Region and local sponsors to identify projects older than 10 years, meets quarterly



with ALDOT East Central Region to review the inactive project list, as well as keeps a spreadsheet to track changes in funding.

The MPO staff stated that even with all the existing project status tracking mechanisms in place, the MPO still finds it challenging to keep up with the status of all projects within the MPA, especially projects that are sponsored by ALDOT and municipalities. The MPO also stated that tracking the status of all projects within the MPA regardless of sponsorship will continue to be an ongoing effort, and the MPO staff plan to continue to update the list of all active projects as projects are completed, deleted, or closed out.

In its effort to meet requirements mandated by 2 CFR 200, ALDOT issued a policy directive in 2015 concerning the project agreement end date. The policy directive provided guidance on determination of a reasonable project end date for a new PE, RW, or CN authorization. Many ALDOT Regions, MPOs and municipalities have not been made aware of this policy directive since its issuance in 2015.

4.6.3 Findings

Commendation: None

Corrective Action: None

Recommendations:

- Keeping up with status for all projects within the MPA is a joint responsibility of the MPO, ALDOT, and municipal sponsors. The MPO should continue to work with ALDOT and municipalities to develop a comprehensive process or tool that would enable the MPO staff to not only keep up with the status of all projects within the MPA, but also cost estimate and scheduling for the RW, UT, or CN phase of each project that has yet to be authorized to ensure the financial constraint of the TIP and RTP, as well as the consistency and feasibility in scheduling for the RW, UT, or CN phase of each project in the TIP and RTP. The process should also enable the MPO staff to generate a report to inform the MPO Policy Committee and the public the status of all projects within the MPA monthly, quarterly or semiannually. The MPO staff should consider including the following information for every project in the status report:
 - Project number, sponsor, scope (PE, RW, UT, CN), and description;
 - Project authorization date;
 - > Total project amount, expenditure amount to date, and remaining balance;



- Completion date if a project has been completed;
- Reason for delay if a project is delayed;
- Updated project Start and End Date if there is any change;
- Proposed start dates for RW, UT, and CN phases as programmed in the TIP and RTP if the PE phase has already been authorized, etc.
- The MPO should be aware of the policy directive issued by ALDOT concerning project end date as listed in Appendix E of this report.

<u>Schedule for Process Improvement:</u> The MPO should implement the recommendations by the next Certification Review.

<u>Proposed FHWA/FTA Technical Assistance:</u> FHWA and FTA will provide technical assistance as requested.

5.0 CONCLUSION AND RECOMMENDATIONS

The Federal Review Team found that the metropolitan transportation planning process conducted in the Birmingham urbanized area meets Federal planning requirements as follows.

5.1 Commendations

The following are noteworthy practices that the Birmingham MPO is doing well in the transportation planning process:

- Citizens participated at the public involvement meeting during the on-site review commended the MPO staff for their responsiveness and professionalism;
- The MPO staff was enthusiastic, receptive and accommodating throughout the certification review;
- The MPO's approach to involve and engage the public was innovative, creative, and effective during the development of the B-Active Plan, Freight Plan, and 2045 RTP. The amount of participation and input from the public was substantial;
- The MPO led and assisted all 59 member governments in the development of ADA
 Transition Plans for their respective areas;
- The RPCGB provides and leads two major initiatives, CommuteSmart and Alabama Partners for Clean Air to promote cleaner modes of transportation, and improve air quality for the Birmingham metropolitan planning area.



5.2 Recommendations

The Federal Review Team made several recommendations to the MPO. Detailed descriptions for these recommendations can be found in sections 4.1 through 4.6 of this report.

5.3 Training and Technical Assistance

FHWA and FTA will provide technical assistance as requested by the MPO.





Project End Date Policy Directive

As you are aware, due to the requirements set forth in 2 CFR 200, project end dates must now be provided to the Federal Highway Administration (FHWA) for any new project authorization. This encompasses the preliminary engineering, right-of-way, utility, construction, and "other" scopes. Furthermore, any project modification that "... amends the terms and conditions of the Federal award" (2 CFR 200 Implementation Guidance) must also have an end date provided. Therefore, the following guidelines should be utilized to determine a reasonable project end date:

Construction and Utility Authorizations/Modifications

The end date for a new construction or utility authorization should include the letting and contract execution period, if applicable, estimated construction time, and an additional three year time frame. In addition, any delay work or procurement time special provisions, possible letting delays, utility delays, etc., should also be considered when establishing the end date. When an end date for a construction or utility modification is required, the date should consider the remaining construction time as well as the factors previously noted, if applicable.

Right-of Way (ROW) Authorizations/Modifications

The end date for a new ROW authorization should be 5 years from the authorization submittal date. Furthermore, any ROW modification requiring an end date should consider the time remaining of the original 5 year period, progress of the ROW requisition, and construction status.

Preliminary Engineering (PE) Authorizations/Modifications
 The end date for a new PE authorization should be 5 years from the authorization submittal date. More time may be required for projects that involve more complex environmental studies and analysis. Furthermore, any PE modification requiring an end date should consider the time remaining of the original 5 year period and the right-of-way acquisition and construction statuses.

These project end dates are very important and should be considered carefully so that federal reimbursement is not adversely impacted. If you have any questions, please do not hesitate to contact me at 26319.




